## 1 SECTION 1. SHORT TITLE. This Act may be cited as the "VA Emergency Trans-2 3 portation Access Act". SEC. 2. AUTHORITY FOR CHANGES TO DEPARTMENT OF 4 5 VETERANS AFFAIRS RATE OF PAYMENT OR 6 REIMBURSEMENT PROVIDED FOR TRANS-7 PORTATION OF VETERANS AND OTHER ELIGI-8 BLE INDIVIDUALS ON SPECIAL MODES OF 9 TRANSPORTATION. 10 (a) In General.—The Secretary of Veterans Affairs may not change the rate of payment or reimbursement 11 provided for the transportation of a veteran or other eligi-13 ble individual on a special mode of transportation, as in effect on January 1, 2023, unless— 15 (1) such change would increase the rate of such 16 payment or reimbursement; or (2) before the effective date of such change, the 17 18 Secretary— 19 (A) conducts a thorough review and anal-20 ysis of— 21 (i) the economic effect of the change 22 on the Department of Veterans Affairs; 23 (ii) the economic effect of the change 24 on the industry associated with the special

9	(b) Consultation Requirement.—The Secretary
10	shall carry out any review under subsection (a)(2)(A) and
11	develop any process under subsection (a)(2)(B) in con-
12	sultation with a committee made up of each of the fol-
13	lowing, who shall be appointed by the Secretary:
14	(1) Relevant industry experts.
15	(2) Representatives of the Centers for Medicare

14	(d) Special Mode of Transportation.—In this
15	section, the term "special mode of transportation"—
16	(1) means an ambulance, ambulette, air ambu-
17	lance, wheelchair van, or other mode of transpor-
18	tation specially designed to transport disabled per-
19	sons; and
20	(2) does not include—
21	(A) a mode of transportation not specifi-
22	cally designed to transport disabled persons,
23	such as a bus, subway, taxi, train, or airplane;
